

## SCHOOL EYE TEST

### With the Orthoptist

Dear Parent/Guardian

The children will be having their eyes tested in the next few weeks at school. This is a routine test to detect reduced vision.

Children rarely complain of having poor vision and it can easily go un-noticed especially if it only affects one eye.

Your child will be asked to wear an eye patch during the test so that we can test each eye separately. They will match letters and look at pictures; all the tests are made into child friendly 'fun' games.

All staff involved in vision screening will follow local and national guidance on infection control and a risk assessment will be carried out prior to the visit.

- If you **do** wish your child to have this assessment you do not need to take any further action.

**Include your child's name, date of birth and the school they attend.**

Your child's name and date of birth only will be requested from school prior to our visit.

After our visit if your child needs a further assessment, we will ask school for their current address and telephone number. If your child is not registered at the local hospital, we will also ask for your name and family GP details.

We will inform you of the result of the eye test which may also be given to the teacher if it is in the child's best interest.
